## Product Description

**Stoner® M800 Urethane Mold Release** is specially formulated as a heavy-duty release agent and anti-stick lubricant for molded urethanes and similar materials. Provides fast, easy part removal from molds and multiple part releases per application. Improves molding efficiency in many processes including injection, pour cast, and extrusion molding. Economical – a light coating produces best results.

- Improves part appearance and reduces defects caused by sticking.

## Uses

**Stoner® M800 Urethane Mold Release** is a heavy-duty release agent and anti-stick lubricant for molded urethanes and similar materials. Useful for difficult molds and hard to release parts.

## Direction for Use

### Recommended Procedure

This material is ready-to-use and requires no dilution. Best application is achieved by applying a thin coating using a wiping, brushing or spraying. The ideal application is to evenly wets the surface and dries to a glossy layer of mold release. Over-application can result in drips, runs or puddles of release that can cause part defects. If over applied, remove the excess with an absorbent cloth prior to molding. Some

customers find a brush useful to even out the Stoner® M800 mold release on complicated molds. Best results are obtained when release is applied shortly before molding. Treated molds heated for more than 30 minutes at 250°F may require touch-up prior to molding. Call for special instructions if parts will be painted, glued or over-molded.

## Storage and Handling

See MSDS for complete instruction prior to use. Do not use near ignition sources. Do not expose container to heat or store at temperatures above 120 °F. This product contains flammable solvents and proper ventilation and static controls should be used. Proper eye and skin protection should be used and some operators prefer to wear an apron when applying release or handling parts.
